



WEDDING CONTRACT AGREEMENT

This Agreement is made between Kristen Dupuis and the wedding couple:

____ Kristen Dupuis agrees to provide Service to the Couple on the date of: _____

____ Kristen Dupuis agrees to be available in assistance with the couple in providing support and guidance during the planning stages of the wedding ceremony and through the final vows of the wedding ceremony itself.

____ Kristen Dupuis agrees to perform the ceremony in a respectful and professional manner in accordance with the ceremony planned by the couple. Kristen Dupuis will dress appropriately for the wedding and arrive early on the day of the ceremony. In the unlikely event that Kristen Dupuis is unable to attend (Death, illness, Injury) She will do her absolute best to have a replacement **or** complete refund all monies paid to her in full.

____ Kristen Dupuis agrees to sign the legal Marriage Documents in the presence of Witnesses and to send it in to the Government ONE day after the wedding. (* If the couple is already legally married to each other No legal action required)

PAYMENTS: (Both Parties to Initial)

_____ A Deposit will be made at the time of booking to secure your Time and Date. The Deposit will be in the amount of **\$100.00** (*This is Non-Refundable.*) This Deposit will henceforth guarantee the services of Kristen Dupuis and will prevent her from booking any other wedding for this Time and date.

_____ Full Payment will be made to Kristen Dupuis **NO** later than **One week** Prior to the Ceremony. (This Payment will be for the Remaining Balance of \$200)

_____ Kristen Dupuis will attend Your Rehearsal for an Additional Fee of \$100.

_____ If for any reason the Wedding couple decides to cancel the Services of Kristen Dupuis, the couple must provide written (Email or Letter) AT LEAST 7 days prior to the wedding. If the Couple fails to provide written notice the couple will be responsible for the remainder of the balance owing to Weddings By Kristen Dupuis.

_____ Kristen Dupuis and The Couple are now entering into a Legal Contract with one another, all parties will act in good faith, keep open and Honest Communications with one another for the Length of the Contract.

IN WITNESS WHEREOF, the parties hereto agree to the terms and conditions as described above and have caused this Contract to be signed on the dates indicated below. This contract, once signed, is considered by all parties within to be legal and binding in accordance with the conditions set forth herein, and shall abide by the agreed upon terms. The parties agree that the specifics of the agreed ceremony shall be considered a part of this contract after signing.
